THE LOCAL MALARIA BURDEN IS EXACERBATED BY (I) SUBSTANDARD HOUSING CONSTRUCTION THAT ALLOWS EASY INSECT-ENTRY AND (II) THE DEVELOPMENT OF DRUG RESISTANCE TO BOTH MEDICATION AND INSECTICIDE.
